**COURSE DESCRIPTION:** This course provides an interdisciplinary survey of the American cultural, social, and political experience. Emphasis is placed on the multicultural character of American society, distinctive qualities of various regions, and the American political system. Upon completion, students should be able to analyze significant cultural, social, and political aspects of American life. This course has been approved to satisfy the Comprehensive Articulation Agreement general education core requirement in humanities/fine arts.

**SUPPLEMENTAL RESOURCES:** Students will be expected to use the resources of the College Library and NC Live in preparing course assignments. Orientation to Library resources will be provided by the Library staff.

**LEARNING/TEACHING METHODS**: Lectures, class discussions, supplemental information, written assignments, outside reading assignments, projects as assigned.

OUTSIDE READING ASSIGNMENTS: Students will be assigned outside reading for this course, with reading/research forming the basis for a written report, an oral report and team assignments.

This course is a rigorous course and studies move rapidly as we investigate source documents from a number of periods in American history. It will demand considerable time and effort on your part both inside and outside of

class. To be successful in this course, for each hour the class meets students should anticipate devoting 2 to 3 hours of study outside of class.

**STUDENT ATTENDANCE POLICY:** Martin Community College recognizes that academic success is tied to regular attendance and completion of assigned work and tasks in a timely manner. Students who wish to be excused for a Religious Observance required by their faith must complete and submit a request form to the instructor(s) <u>prior to the census date of each class.</u> The *Request for Excused Absences for Religious Observances* can be picked up from Student Services. This does not supersede the college-wide attendance policy as outlined in the college catalog or syllabus, with the exception of a reasonable accommodation for the make-up of missed course work.

**COURSE POLICIES:** All tests and exams are mandatory. An unexcused missed test will be given a grade of zero. Should you find that you will be unable to take a test or exam on the scheduled date, you must notify the instructor in advance.

Late Work: Students are encouraged to turn in all assignments on time. Five points are deducted per day for late work.

Plagiarism: The Honor System is in place in this class. Student submitting work that is not their own (an act of plagiarism) risk receiving a zero and a grade of "F" on the course.

Behavior: Positive behavior is expected at all time during the class.

Academic Integrity: In addition to good academic performance, students should exhibit honesty and integrity. If there is any question that academic honesty and integrity are not honored, students may be required to redo assignments in the presence of an instructor-selected monitor. Other actions, in accordance with college policy, may be taken. Proof of dishonesty, including plagiarism, will make students subject to disciplinary action.
