**COURSE DESCRIPTION:** The course continues horse industry and practices and emphasizes basic horse husbandry and stable management practices. Topics continue from EQU 111 and include prevention, identification and treatment of diseases, injuries and treatments, lameness, parasites, and common medications. Upon completion, students should be able to further perform horse husbandry and stable management practices and explain related theory.

## PROGRAM LEARNING OUTCOMES:

- 1. Demonstrate the level of responsibility, work ethic necessary to be effective and successful in the Equine Industry.
- 2. Assess equine injuries and apply first aid while utilizing proper saftey techniques.
- 3. Demonstrate a balanced seat, the proper use of natural and artificial aids while applying basic riding and training techniques to green and broke horses.

#### **COURSE LEARNING OUTCOMES:**

- 1. Explain equine behavior and physical makeup.
- 2. Demonstrate the ability to take vitals.
- 3. Discuss general knowledge of common illness and injury and the proper treatment for each.

- 2. Demonstrate the ability to administer proper medication for illness or injury.

# **LEARNING/TEACHING METHODS:**

Lecture, Class Discussion, Outside Reading Assignments, Writing Assignments, Individual Projects, Class Projects, and Hands on Activities

## ASSESMENTS/METHODS OF EVALUATION:

- 1. Tests: Can cover any material covered in lecture, lab, textbooks, handouts, clinics or videos. They can be both written and practical.
- 2. Horse Care Practical: Students are expected to finish tasks in a competent and timely manner according to the specifications of the Horse Science Handbook. When absent, you may choose to find a substitute to cover your feed crew and horse care responsibilities to prevent you from losing points for the day. Failure to do so will result in a loss of points for the day and may have a negative impact on your horse care grade. This is true for both excused and unexcused absences. Instructor must be notified in the case of a substitute for feed crews and the Keeper must be notified in the case that you are getting a substitute to perform your horse care responsibilities.
- 3. Professionalism and attitude will be reflected in all aspects of your grade. Attached Rubric guidelines will be used to determine this grade and will also be factored into your weekly grade. Students are expected to always maintain a good attitude and act in a professional manner with the instructor, other students, horses, and guests. ANY student speaking or acting in a disrespectful way to an instructor, another student, or guest will AUTOMATICALLY receive a 0% F for their weekly grade!
- 4. Final Exam: Will be comprehensive.
- 5. Weekend Duties: See Horse Science Handbook and below absence policy #2.
- 6. Assignments: Students will be asked to write papers or answer questions pertaining to the information that is being covered in class.
- 7. Outside Reading Assignments: Students will be asked to read bi weekly articles from the www.thehorse.com website that pertain to the material that is being covered in the class at that time. They will be asked to write summaries on each of the articles. I will grade the summary using the attached Reading Response Rubric.

#### **TESTING POLICY:**

All tests will be posted at the start of the semester and students may work ahead if they so desire. All of the tests have due dates that can be found on the link to the actual test, on the course schedule, or on the course calendar on Blackboard. Not checking the web site often enough is not an excuse for not having completed a test.

The tests are set up to force completion. What this means is that once you open the test, you must finish it. The computer will not allow you to reopen the test later. The computer will pull questions from a random pool of questions, so no two tests are alike. I will grade the tests in 1 week of the due date.

Tests will not be able to be made up. So be sure that you plan ahead.

#### **EXTRA CREDIT:**

Extra Credit In the Lecture Portion of the Class: Extra Credit is available on an individual basis. You will be assigned a project that pertains to what we are covering in class at the current time.

Extra Credit In the Lab Portion of the Class: May be available, but on an individual basis, and this must be discussed with the Farm Manager.

## MAKE UP WORK:

Work missed in the lecture portion of the class, (NOT including TESTS) will be accepted but will only receive half credit, and must be turned in within 2 weeks of the due date. Homework assignments # 26 – 29 will not be accepted late. Article Summary # 8 will not be accepted late.

Work missed in the lab MAY be allowed to be made up, but students must discuss this with the Farm Manager and their assigned sophomore on an individual basis.

# **OUTSIDE READING ASSIGNMENTS:**

Students will be asked to read bi-weekly (possibly more) articles from various websites that pertain to the material that is being covered in the class at that time. The instructor will be choosing the majority of the articles, so we will know that the material is current and correct. The student will then be asked to write summaries on each of the articles. These articles will be posted in the assignment section of Blackboard along with their homework. The article summaries will be posted at the beginning of the semester, and students will be allowed to work ahead if they so desire. Work missed in the lecture portion of the class, (NOT including TESTS) will be accepted but will only receive half credit, and must be turned in within 2 weeks of the due date. Homework assignments # 26 – 29 will not be accepted late. Article Summary # 8 will not be accepted late. I will grade the article summaries within on week of the due date. I will grade the summary using the attached Article Summary Rubric.

#### **HOMEWORK:**

You will be given a homework assignment to do for every section of material that we cover. The assignments will be posted at the beginning of the semester, and students will be allowed to work ahead if they so desire. The homework assignments will have due dates on them that can be found on the link to the actual assignment, on the course schedule, or on the course calendar on Blackboard. The week to week breakdown on the homework assignments and corresponding due dates can be found on Blackboard. I will grade the homework assignments in 1 week of the due date. Work missed in the lecture portion of the class, (NOT including TESTS) will be accepted but will only receive half credit, and must be turned in within 2 weeks of the due date. Homework assignments # 26 - 29 will not be accepted late. Article Summary # 8 will not be accepted late.

- 1. **STUDENT ATTENDANCE POLICY:** Students will be allowed to have 5.3 hours of unexcused absences and 11 hours of excused absences. In order for an absence to be excused, the student must receive permission from the instructor prior to the absence, and provide documentation for the reason of the absence. The student is expected to make up any missed work and may be required to do an additional assignment. Absences may be excused at the discretion of the instructor for the following reasons: IHSA, doctor visits, legal proceedings, SGA, and pre-approved equine events. When a student is over 15 minutes late to class or to weekend duties, he or she will be considered absent.
- 2. In case of absences on assigned weekends, it is the student's responsibility to find another student to cover all of his/her barn duties. The first time the student is absent without a substitute, the students

grade IN THE COURSE will drop one letter. The second time it will drop the grade IN THE COURSE another letter, and the third time it will result in a failure of the course. Absences are calculated not by the weekend, but by the day. This means that being absent from an entire weekend will drop the students grade IN THE COURSE by two letters. Substitutes are to perform all tasks assigned to the absent student and any others as indicated by the instructor or sophomore in charge that weekend. Student and substitute must sign as substitution sheet by 5 P.M. on Friday or the day proceeding the assigned weekend, if different. Once a substitution sheet is signed, the substitute assumes full responsibility for the assigned weekend. If students are 15 minutes or more late for either feed time or from getting back from lunch, they will be considered absent. When students are late (under 15 minutes) they will receive a letter grade drop in their weekend duties grade.

3. When absent, you may choose to find a substitute to cover your feed crew and horse care responsibilities to prevent you from losing points for the day. Failure to do so will result in a loss of points for the day and may have a negative impact on your horse care grade. This is true for both excused and unexcused absences. Instructor must be notified in the case of a substitute for feed crews and the Keeper must be notified in the case that you are getting a substitute to perform your horse care responsibilities.

# REQUEST FOR EXCUSED ABSENCES FOR RELIGIOUS OBSERVANCES\*

\*In compliance with G.S. 115D-5, MCC policy permits a student to be excused, with the opportunity to make-up any test or other missed work, a minimum of two excused absences per academic year for religious observances required by the student's faith. The policy limits the excused absences to a maximum of two days per academic year.

Students who wish to be excused for a Religious Observance required by their faith must complete and submit a request form to the instructor(s) <u>prior to the census date of each class.</u> The **Request for Excused Absences for Religious Observances** form can be picked up from Student Services. This does not supersede the college-wide attendance policy as outlined in the college catalog or syllabus, with the exception of a reasonable accommodation for the make-up of missed course work.

## **COURSE POLICIES:**

Students must receive a score of 60% or better in both the lab and lecture portions of the class in order to pass the class as a whole. Failure to receive a score of 60% or better, in one or both portions of the class, will result in a failure of the entire course.

#### SAFETY:

There will be many days when we are in the barn or arena looking at horses. So, you will be required to wear proper attire, boots with a heel and long pants at all times when class is in session. If you show up to class in attire that does not meet this requirement, you may be sent home and that class period will count against your unexcused absences. Please refer to your Equine Handbook for more information on safety issues.

# ADMINISTRATIVE WITHDRAWL POLICY:

Students must be present in at least one class during the first 10% of the course in order to be considered enrolled in the course. Students who do not attend the course by the census date will be administratively withdrawn from the course by the instructor and will not be allowed to attend the class. In addition, instructors may administratively withdrawal a student missing 6 continuous hours or failing to attend the required percentage of total hours of a course without a justifiable absence and verifiable contact with the instructor. The instructor also retains the right to administratively withdrawal any student who does not comply with the

rules and requirements of the course. Students will receive a grade of "WF" for the administrative withdrawal. The "WF" will be equivalent to an "F" which will be calculated into the students GPA.
