COURSE DESCRIPTION: This course provides in-depth study of diagnostic coding. Emphasis is placed on ICD-9-CM coding systems. Upon completion, students should be able to properly code diagnoses in a medical facility.

The Martin Community College attendance Policy (Martin Community College Career Catalogue Addendum for fall 2007) is in effect, as well as the administrative withdrawal policy (Martin Community College Career Catalogue addendum for fall 2007).
